**A Resolution Ratifying Executive Order 2020-03
(Sunset of Executive Order 2020-02)
Kane and Kendall Counties, Illinois**

WHEREAS, on March 18, 2020, the Village President of the Village of Montgomery issued a Proclamation of Local State of Emergency/Disaster and Executive Order and a Resolution Authorizing the Village President to Declare and Extended State of Emergency/Local Disaster; and,

WHEREAS, on March 31, 2020, the Village President of the Village of Montgomery issued Executive Order 2020-02, as ratified by the Village Board by Resolution No. 2020-006 which provided for certain financial assistance with regard to water billing; and,

WHEREAS, such measures have provided significant relief to Village residents and have accomplished the objectives of the Village in enacting said policy; and,

WHEREAS, on July 10, 2020, the Village President signed Executive Order 2020-03 sunsetting the terms of Executive Order 2020-03, so that they will no longer remain in force and effect.

WHEREAS, the Village no longer deems it necessary to keep such measures in place and wishes to ratify the sunset provision set forth in Executive Order 2020-03.

NOW, THEREFORE, BE IT RESOLVED, by the Village President and Board of Trustees, Kane and Kendall Counties, Illinois, as follows:

- 1. Ratification of Executive Order 2020-03.** The Village Board hereby finds that the actions taken through Executive Order 2020-03 are in the best interest of the Village and its residents and hereby ratifies and fully supports the actions set forth therein.

This Resolution shall be in full force and effect from and after its passage and approval, as provided by law.

EXECUTIVE ORDER 2020-03

Sunset of Executive Order 2020-02

Village of Montgomery, Kane and Kendall Counties, Illinois

July 10, 2020

I, Matthew Brolley, as Village President of the Village of Montgomery, Kane and Kendall Counties, Illinois, do hereby issue this Executive Order for the Village of Montgomery this 10th day of July, 2020. This Order is issued pursuant to the Illinois Municipal Code (65 ILCS 5/11-1-6); the Illinois Emergency Management Agency Act (20 ILCS 3305/11); and the Village of Montgomery Village Code Section 6 ½-13.

WHEREAS, on March 18, 2020, the Village President of the Village of Montgomery issued a Proclamation of Local State of Emergency/Disaster and Executive Order and a Resolution Authorizing the Village President to Declare an Extended State of Emergency/Local Disaster; and,

WHEREAS, on March 31, 2020, the Village President of the Village of Montgomery issued Executive Order 2020-02, as ratified by the Village Board by Resolution No. 2020-006 which provided for certain financial assistance with regard to water billing; and,

WHEREAS, such measures have provided significant relief to Village residents and have accomplished the objectives of the Village in enacting said policy; and,

WHEREAS, the Village no longer deems it necessary to keep such measures in place.

NOW, THEREFORE, in accordance with the foregoing, I find that the Village has accomplished its objectives as set forth in Executive Order 2020-02 and find that the emergency relief provisions set forth therein are no longer necessary. Accordingly, the terms set forth in Executive Order 2020-02 shall be deemed expired and shall no longer be in force and effect.

This Order shall take effect immediately.
