We will be serving the following items from the cart.


Hot Dogs, Brats, and Polish Sausage all served on buns

Soda and Bottled Water


Pre-Package and individual sized chips and cookies

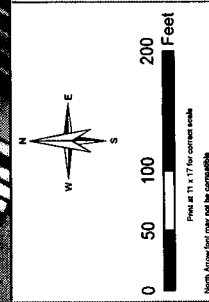
